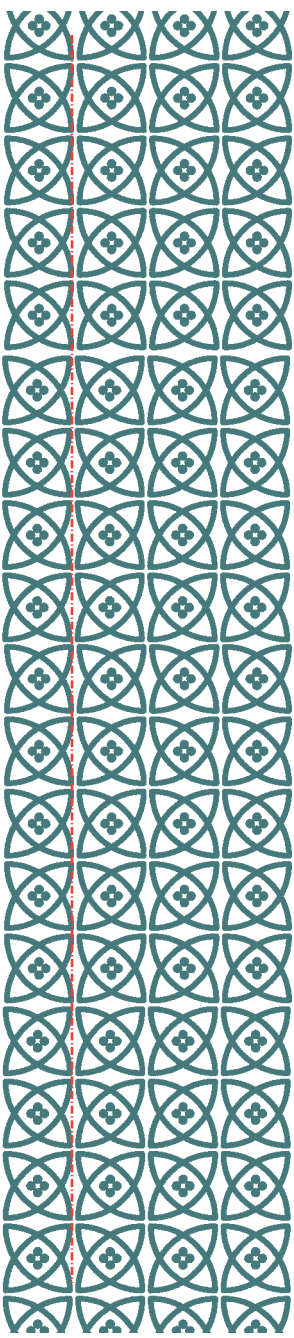

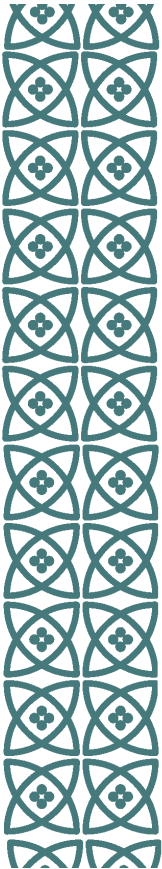

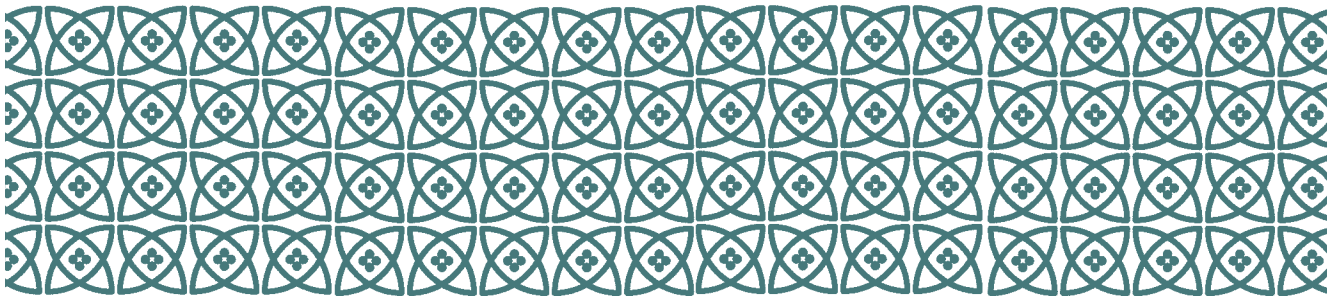

DO NOT TAKE PLEASANTVILLE 117

From the Taconic State Parkway:

Take the Briarcliff Manor exit that reads "Pleasantville Road." Do not take Pleasantville 117. Make left onto Pleasantville Road and follow to the end. At the T, make a left onto South State Road, then immediately turn right onto Elm Road and then another immediate right onto Pine Road. Proceed on Pine Road. Entrance is on the right side.

From New York City:

FDR Drive North to Major Deegan Expressway North (I-87) or Henry Hudson Parkway to Saw Mill River Parkway North to Taconic State Parkway North. Follow directions above from Taconic State Parkway North.

From New Jersey:

Holland Tunnel/George Washington Bridge. Proceed North on West Side Drive to Saw Mill Parkway North. Proceed as from New York City.

OR

Garden State Parkway to NY State Thruway to Tappan Zee Bridge. Take I-287 East (Cross Westchester Expressway) to first exit for Saw Mill River Parkway North to Taconic State Parkway North which becomes the Taconic State Parkway. Follow the directions above from Taconic State Parkway.

From Connecticut:

I-95 South or Merritt Parkway South to I-287 West (Cross Westchester Expressway) to exit 3-Sprain Brook Parkway North which becomes the Taconic State Parkway. Follow directions above from Taconic State Parkway North.
